#### 506 Student Accommodation Charges 2024-25 (Bursar)

(CC.2324.506)

Senior members of Council **approved** the Finance and Needs Committee's recommendation to:

#### CC.2024.02.21 Unreserved Minutes

- increase the accommodation charge by 4.2% in line with inflation (CPI(H));
- b) discontinue cohort pricing going forward, whilst retaining it for the remaining undergraduate and postgraduate students from the 2021 cohort and earlier who were in College accommodation;
- c) remove the vacation premium of 5%;
- d) retain the room bandings from this year's review for three years, subject to an annual meeting between student representatives and the Accommodation Team to review rooms where students have queried the banding;
- e) widen the differential between the highest and lowest rents to increase the affordability of the lower-banded rooms, via a sliding scale of increases from 5.4% for Band A to 3% for Band E, the average increase remaining 4.2%;
- f) increasing rent bursaries from 9.5% to 10% of weekly Band C rent for all Cambridge Bursary Scheme holders in College accommodation.

### 507 Private Undergraduate Fee 2025-26 (Bursar)

Council **approved** the Finance and Needs Committee's recommendation to increase the private undergraduate fee by 7% to £12,840 for the 2025-26 cohort.

Our Future: Leadership Development Proposal (Registrar) (CC.2324.508)

Council, noting that no precedent would be set and acknowledging the opportunity to consider further how the College could engage within the wider community and encourage students to think about their future careers and community roles, agreed to host the Our Future event with the College covering the accommodation and cafeteria-style dining costs.
